Question 1: Shall the Town of Middlefield increase the Levy Limit by \$60,000.

ARTICLE 2. To hear the report of the Selectmen, Treasurer, Tax Collector, Assessors and the School Committee and act thereon.

ARTICLE 3. To see if the Town will vote to fix the salaries and compensation of all elected officers of the Town for Fiscal 2004, as provided in Section 108 of Chapter 41 of the Massachusetts General Laws, as amended; or take any other action relative thereto:

ARTICLE 11. To see if the Town will vote to raise and appropriate the sum of \$349,009 for Middlefield's minimum contribution of the budget for the Gateway Regional School District; or take any other action relative thereto.

ARTICLE 12. To see if the Town will vote to raise and appropriate the sum of \$118,663 for Middlefield's share of the over-minimum contribution to the budget for the Gateway Regional School District or accept as an over-minimum contribution a sum which is less than \$118,663 as certified by the Gateway Regional School District; or take any other action relative thereto.

ARTICLE 13. To see if the Town will vote to raise and appropriate or transfer from available funds now in the treasury the sum of \$63,727 for Middlefield's share of the Transportation and Debt Service (non-foundation budget) and Construction for the Gateway Regional School District; or take any other action relative thereto.

ARTICLE 14. To see if the Town will vote to raise and appropriate the sum of \$10 for vocational education.

ARTICLE 15. To see if the Town will vote to transfer from the Refunded Dog Tax Fund the sum of \$236.93 to the Library Account; or take any other action relative thereto.

ARTICLE 16. To see if the Town will vote to raise and appropriate sum of \$9,526 to pay for the note on the new police vehicle; or take any other action relative thereto.

ARTICLE 17. To see if the Town will transfer \$50,000 from *free cash* to offset the tax rate; or take any other action thereto.

ARTICLE 18. To see if the Town will enact a temporary tax amnesty program during FY2004, in accordance with Chapter 4 Section 73 of the acts of 2003, in order to encourage the payment of certain delinquent tax obligations; or take any action thereto.

Section 1. Amnesty Period: The amnesty program shell begin on May 3, 2004 and end on June 28, 2004 at 7:30pm

Section 2. Program Scope: The amnesty program of the Town of Middlefield will include real estate taxes, personal property taxes prior to 2004. The taxpayer will still be responsible for the assessed tax, penalty fees and demand charges. 100% of interest will be waived. A taxpayer must satisfy all outstanding taxes under the amnesty program. The Town will only accept one single payment for all tax liabilities. Payments must be made in cash, certified check, or bank check and must be made before 7:30pm on June 28, 2004.

ARTICLE 19. To see if the Town will vote to authorize a revolving fund under Massachusetts General Law Chapter 44, Section 53E, half of which may be spent on the Transfer Station without further appropriation during FY2004. Collected Transfer Station fees may be used for the Transfer Station, for capital equipment, grounds improvement or other related expenses to benefit the Transfer Station. The Selectmen may spend up to \$5,000 in revolving fund monies for the program during FY2004; or take any other action relative thereto.

ARTICLE 20. To see if the Town will vote to accept Franklin Regional Transit Authority as the official transportation agent for the Council on Aging; or take any other action relative thereto.

ARTICLE 21. To see if the Town will vote to the changes in Town Bylaws, or take any action thereto.

Chapter II Section 8. Eliminate Tree Warden elected position and incorporate it into the Superintendent of Streets appointed position.

Chapter IV Article II Section 2. <u>Delete as written</u>: The building Inspector shall also be the Board of Health agent for observing percolation tests and septic systems. <u>Replace with</u>: An appointed agent will be designated by the Board of Health to observe percolation tests and septic disposal systems.

Chapter IV Article II Section 3. <u>Delete section 3</u>: Season for percolation tests is April 1 (if frost is out of the ground) to June 15, and can be extended by the Board of Selectmen acting as the Board of Health.

Chapter IX. Add a new Section 7 to Miscellaneous Provisions that would read as: "No public or private utility and/or construction company shall work on any public way within the town without notifying the Police, Chief or his/her designee. All road details shell be assigned by the Police Chief or his/her designee."

ARTICLE 22. To see if the Town will vote to remove from Table 3.0 the special permit requirements in the Business Zoning District for the Types of Land Use under the following sections of Bylaw Number **3.04**:

- **3.044** Office, bank, newspaper, job printing establishment
- 3.045 Hotel, motel, restaurant
- **3.046** Any wholesale or retail business, research laboratory, service of a public utility, or light manufacturing
- **3.047** Automobile service station, repair shop, storage garage, or salesroom

by changing the "SP" designations in the "Business" column "Y*";

while adding to Bylaw Number **3.04** under the "Standards and Conditions" column the wording "Business Uses marked as allowed by right (Y*) shall not include any use that involves demolishing or significantly altering them from their residential appearance. Such instances shall require a Special Permit (SP)";

while adding to the abbreviation key below the Zoning Table the definition " $Y^* = See$ Bylaw 3.04 Business Use Standards and Conditions", or take any action thereto.

(The Planning Board voted unanimously not to make this change.)

ARTICLE 23. To see if the Town will vote to change Table 3.0 the use regulations Agricultural-Residential Zoning District for the Types of Land Use under the following sections of Bylaw Number **3.04**:

- **3.044** Office, bank, newspaper, job printing establishment
- **3.045** Hotel, motel, restaurant
- **3.046** Any wholesale or retail business, research laboratory, service of a public utility, or light manufacturing
- **3.047** Automobile service station, repair shop, storage garage, or salesroom
- **3.048** Place of amusement or assembly
- **3.049** Club conducted for profit

by changing the "N" designation in the Agricultural-Residential column to "SP Sec 4.7";

while adding to the abbreviation key below the Zoning Table the definition "SP Sec 4.7 = Permitted by Special Permit under Sec 4.7 Home-based business bylaw";

while deleting from "Standards and Conditions" for sections **3.043** and **3.046** the words "in the business district," or take any action thereto.

(The Planning Board voted unanimously not to make this change.)

ARTICLE 24. To see if the Town will vote to allow all one-family dwellings to be eligible for conversion to a two-family dwelling by deleting from Section **3.034** under "Standards and Conditions" the words "Single family dwelling must have existed at the time of adoption of zoning bylaw," or take any action thereto.

(The Planning Board voted unanimously not to make this change.)

ARTICLE 25. To transact any other business to come before said meeting.
