ARTICLE 13. To see if the Town will vote to raise and appropriate the sum of \$387,515 for Middlefield's minimum contribution of the budget for the Gateway Regional School District; or take any other action relative thereto.

ARTICLE 14. To see if the Town will vote to raise and appropriate the sum of \$102,856 for Middlefield's share of the over-minimum contribution to the budget for the Gateway Regional School District or accept as an over-minimum contribution a sum which is less than \$102,856 as certified by the Gateway Regional School District; or take any other action relative thereto.

ARTICLE 15. To see if the Town will vote to raise and appropriate or transfer from available funds now in the treasury the sum of \$78,202 for Middlefield's share of the Transportation and Debt Service (non-foundation budget) and Construction for the Gateway Regional School District; or take any other action relative thereto.

ARTICLE 16. To see if the Town will vote to raise and appropriate the sum of \$10 for vocational education.

ARTICLE 17. To see if the Town will vote to transfer from the Refunded Dog Tax Fund the sum of \$236.93 to the Library Account; or take any other action relative thereto.

ARTICLE 18. To see if the Town will vote to raise and appropriate sum of \$9,200 to pay for the note on the new police vehicle; or take any other action relative thereto.

ARTICLE 19. To see if the Town will vote to raise and appropriate sum not to exceed \$10,000 to buy financial software for the Town; or take any other action relative thereto.

ARTICLE 20. To see if the Town will vote to authorize a revolving fund under Massachusetts General Law Chapter 44, Section 53E1/2, which may be spent on the Transfer Station without further appropriation during FY2006. Collected Transfer Station fees may be used for the Transfer Station, for capital equipment, grounds improvement or other related expenses to benefit the Transfer Station. The Selectmen may spend up to \$5,000 in revolving fund monies for the program during FY2006; or take any other action relative thereto.

ARTICLE 21. To see if the Town will vote to accept Franklin Regional Transit Authority as the official transportation agent for the Council on Aging; or take any other action relative thereto.

ARTICLE 22. To see if the Town will vote to raise and appropriate \$20,000 to cap the old dump on Skyline Trail; or take any other action relative thereto.

ARTICLE 23. To see if the Town will raise \$10,000 for town's fiscal audit; or take any

other action relative thereto.

ARTICLE 24. To see if the Town will vote to continue membership in the Hampshire Council of Government for FY 2007 through FY 2010 with a 75% reduction in annual dues; or take any other action relative thereto

ARTICLE 25. To transact any other business to come before said meeting.

And you are directed to serve this warrant by posting attested copies of same in the Middlefield Post Office, on the bulletin board at the Town Hall, a designated place in the Bancroft section of the Town and a designated place in Smith Hollow, at least seven days before time of holding said meeting.
